How to participate in #GTO:



Purchase from 3M Authorized Welding Distributor



Distributor must indicate on the 3M order notes: "#GTO, End User Name, Address, City, State, Zip Code"



Begin the 60-day evaluation

To be eligible for participation in this #GTO program, the following conditions must be met.

- The product must be purchased from a 3M authorized Welding Distributor and used in the U.S.
- Distributor must insert in the customer notes section on the order, at the time of order, the following code: "#GTO"
- Distributor must also indicate the End-User Customer on the order at the time of the order.
 - o Example of how to designate a #GTO in the customer notes section on an order
 - § Format: #GTO End User Name, Address, City, State, Zip Code
 - § Example: #GTO 3M, 3M Center, 235-02-W-70, St. Paul, MN 55144
- Any order submitted without meeting these order entry requirements will be considered a standard order and not eligible for the #GTO program.

To complete a return under this #GTO program, please follow the process below:

- End-user customer to inform Distributor they wish to return the product within 60 days of purchase
- Distributor reaches out to 3M Customer Service by email (3msupport.safety.us@mmm.com) and provides original PO # and material number(s) requested to return for credit
- Upon receipt of PO # and material information, 3M Customer Service will verify #GTO eligibility and send a returned goods authorization (RGA) form to the Distributor
- Distributor should then provide the RGA form to the end user for completion
- The end user customer can then ship all relevant product, **including the completed RGA form**, to the 3M address provided below.
- No credit will be issued if all relevant product or RGA form are missing in the return

If the above and full program terms and conditions are met, then 3M will reimburse the Distributor for the order value of the product returned.
